

# Remote Spirit Release – Terms and Conditions & Informed Consent

---

## **Aims and Objectives.**

The primary objective of this procedure is to give aid and assist you in relieving the distress that you or a person close to you may be experiencing due to any discarnate spirit entity including dark force entities (DFE), inter-dimensional species, alien, curse, hex or earthbound spirit (EB).

In addition, a secondary aim is to provide evidence to the psychiatric community that these spiritual procedures work.

## **Methods employed**

The method of intervention employed is the **Remote Spirit Release** method. That is the *only* service offered and we do not offer any emergency service, rehabilitation or ongoing therapy work. Neither do we claim to treat any physical condition including drug or alcohol addiction. However, after the removal of all negative spirit entities and curses the recovery prognosis from all other treatment methods should be greatly improved. When all such negative intrusions are removed our task is deemed completed and any post-intervention aftercare will require the expertise of other healing or medical agencies.

For the **remote** method two practitioners are employed and the procedure is conducted from a distance by telepathic and clairvoyant means. All spiritual work is conducted beyond the physical boundaries of time and space. You therefore will not be aware when the procedure is performed and there will be no need for the patient to be in any particular place at any particular time. You will be informed when the procedure has been completed. The remote method is ideal for patients who are below the age of consent and for those who are too incapacitated or too ill to give consent or are detained within mental health institutions.

## **Definitions of Terms Used**

The person who is the subject of the remote spirit release procedure is referred to as *The Patient*. The person requesting the procedure and taking responsibility for the payment of fees is referred to as *The Client*.

In cases of self-referral, the Client and the Patient are one and the same

## **Payment of Fees**

The total fee for a remote spirit release procedure is £100. When a request for help is submitted by you (The Client) a small deposit of £10 will ensure that your case will be entered into our schedule. On completion of the procedure you (The Client) will be sent a written report that the procedure has been completed. At this point you will be invoiced for the remaining balance of £90. Upon receipt of the balance of £90 you will be sent a recording of the intervention session. For registered Patrons, trainee practitioners and recognised professional colleagues, a 20% discount is to be applied on the balance of £90. The balance is therefore reduced to £72. All invoices to be settled on receipt without delay.

### **Post-intervention follow-ups**

If there is no discernible relief resulting from our intervention within seven days, and on the explicit condition that all advice for self-protection and lifestyle changes have been followed, one free follow-up to see if we have missed anything may be requested and performed by the same interventionist team, and only after payment of the balance has been received.

### **Session Recordings**

All cases are routinely recorded for the benefit of clients and patients in order to aid in understanding the process of remote spirit release procedures. All clients receive an audio recording of their session when their account has been settled. Some cases may be of value in research and for the education of students of spirit release therapy. It is therefore a requirement that all clients give their approval and consent for all recordings to be used in confidence with complete anonymity for educational and research purposes. Therefore, acceptance of these terms and conditions infers automatic authorisation for recordings to be used for education and research.

### **Confidentiality & Anonymity**

Your case is automatically allocated a unique case file number and all personal information is treated with the strictest confidentiality and anonymity. You and all members of your family are assured of absolute anonymity and confidentiality, and under no circumstances whatsoever will your name or any other personal information be disclosed or revealed in any form for any purpose whatsoever.

### **Protection & welfare**

Your welfare is of the utmost importance and you may be assured that all means will be taken for your protection during the procedure.

### **Informed Consent**

Your acceptance of these *Terms and Conditions* is acknowledgement that you give your *Informed Consent*, either on behalf of yourself or a client of your own if you are a medical practitioner or other therapist, or for a friend or family member.

If you are acting on behalf of someone who is not able to give their own informed consent for any reason then, as referrer, you agree to take full responsibility for requesting the scan and intervention on their behalf, and you therefore agree to the terms and conditions contained herein and for the payment of any fees due.

### **Post-intervention Reporting**

It is important that the medical establishment are aware of the efficacy of our interventions and we are duty-bound to submit statistical reports to relevant scientific institutions from time to time when requested to do so. We therefore request that you assist us in this duty and report to us according to your experience of the relief or otherwise of the intervention you have received.
