# Hearing Voices Research Remote Spirit Release In the Search for Best Practice Terms and Conditions & Informed Consent

# Aims and Objectives.

- 1. The aim of this procedure is to give aid in relieving the distress that a family member may be experiencing due to any discarnate spirit entity, including dark force entities (DFE), inter-dimensional species, alien, curse, hex or earthbound spirit (EB).
- 2. Our objective is to provide evidence to the psychiatric community that these procedures work and thereby provide efficacy for evidence-based medicine.

# **Participation Criteria**

Sufferers of *Auditory Voice Hallucinations* (AVH), supported by their respective family members and medical treatment supervisors, are invited to assist with this research.

Responsible family members may act on behalf of and offer the participation of a loved one who may be a minor or incapacitated and unable to give their informed consent.

There are no limitations on age, gender, ethnicity, religious or spiritual beliefs, geographic location or any other demographic factor, but participants must meet the following criteria:

- 1. Hearing voices (Auditory Voice Hallucinations)
- 2. Diagnosed with AVH, psychosis or schizophrenia
- 3. Under supervision from a registered professional.
- 4. The healthcare supervisor agrees to the patient's participation.

# **Designation of Participants**

- 1. The person who is the *subject* of the remote spirit release procedure is referred to as *The Patient* or the *Participant*
- 2. The family member requesting the procedure is known as *The Referrer* and is responsible for accepting these terms and condition on behalf of the Patient/Participant and shall register the Patient as the *Participant*.

- 3. The *Supervisor* is the healthcare professional supervising the medical treatment of the Patient/Participant and shall be referred to as the Research *Collaborator*.
- 4. The *Interventionist* team is comprised of a *Facilitator*, a Spirit *Medium* and a *Spirit Guide*. An Administrator manages all administrative duties.

# Method employed

The Remote Spirit Release method (RSR) is the method of intervention employed. For the *RSR* method, a team of two practitioners, a spirit medium and a facilitator are employed, and the procedure is conducted from a distance by telepathic and clairvoyant means. All spiritual work is conducted beyond the physical boundaries of time and space by the *Spirit Guide*. Therefore, the Patient (Participant) will not be aware when the procedure is performed. There will be no need for the Patient to be in any particular place at any specific time. You, the *Referrer*, will be informed when the procedure has been completed. The remote method is ideal for patients below the age of consent and those who are too incapacitated or too ill to consent or are detained within mental health institutions. All Clients are sent a copy of the method protocol in pdf format with their written report.

Important Note: We cannot be held responsible if the information or names on your referral form are incorrect. Please ensure that all information is accurate before submission as mistakes could result in misdirection, and the outcome will be null and void. Donations to the research fund are not refundable in the event of errors.

### **Research Costs Contribution**

The procedure is to be conducted according to the *Hearing Voices Project Protocol*. Fees are waived due to the research status of this procedure. However, administrative overheads are to be covered by the *Research Fund*. Collaborators, Participants and their Referrers are invited to contribute to the fund by becoming either a *Participant Patron* or a *Research Collaborator* according to participating or collaborating status. Alternatively, participants, referrers and healthcare supervisors are invited to make a free-will donation to the *Research Fund*.

When you submit a request for help, registration of the *Participant* and Research *Collaborator* in advance will ensure that your case will be entered into the research schedule. Only Registered Patrons or Research Fund Contributors of a free-will donation can be accepted into the research schedule.

The method of making a free-will donation is through Pay Pal. The contribution of £100 is only a suggestion and may be amended. The amount will be automatically exchanged according to current foreign exchange rates and shown on your statement in your local currency. No other payment method is employed. If you cannot access Pay Pal from your location, perhaps you can enlist the aid of someone who can. In such a case, please ensure that the contributor's email address is entered correctly on the application form. Errors cannot be rectified.

# **Session Recordings**

All cases are routinely recorded for the benefit of Referrers, Participating Patients and Supervising healthcare professionals to understand the process of remote spirit release

procedures. All Referrers and healthcare supervisors receive an audio recording of their session in MP3 format. Please don't try to play a recording on a device that does not support MP3. Recordings remain our copyright and must not be shared with any other person without our expressed consent.

All cases are important and have value in research and for students of the Remote Spirit Release method. Therefore, it is a requirement that all Clients, participants, and research collaborators give their approval and consent for all recordings to be used in confidence with complete anonymity for educational and research purposes. Therefore, acceptance of these terms and conditions infers automatic authorisation for recordings to be used for education and research.

# **Confidentiality & Anonymity**

Your case is automatically allocated a unique case file number, and all personal information is treated with the strictest confidentiality and anonymity. All referrers, patient/participants and healthcare supervisors are assured of absolute anonymity and privacy. Under no circumstances whatsoever will your name, the Patient, Healthcare Supervisor, Institution or any other personal information be disclosed or revealed in any form for any purpose whatsoever.

## **Protection & welfare**

The remote procedure does not require any direct physical connection or communication with the Patient/Participant. Therefore, there can be no risk of harm of any kind in the intervention with the Remote Spirit Release method.

# **Feedback Reporting**

Providing efficacy of our methods is essential for evidence-based interventions. Therefore, it is respectfully requested that Clients provide feedback after seven days about the effectiveness of the intervention. When reporting back, please indicate the outcome of the intervention by choosing just one result from the following options:

- 1. No change
- 2. Better
- 3. Much better
- 4. A detailed testimonial was given.

# **Informed Consent**

Your acceptance of these *Terms and Conditions* is an acknowledgement that you give your *Informed Consent* on behalf of a Patient/Participant if you are a medical practitioner or family member.

#### Limitations of Service

- It is with regret that we cannot offer 24-hour emergency service.
- We are not able to provide telephone counselling.
- We are not providers of one-to-one therapy of any kind.
- Cases are entered into our schedule only on receipt of a referral form, supported by registration as a Patron or a free-will donation.
- Donations made with errors or omissions on referral forms are not refundable.
- Our office is closed every weekend and all UK national bank holidays are observed.
- Schedules are updated on the first working day of every week.
- Cases are allocated to practitioner teams at the earliest opportunity, dependent on the workload, and cases are generally attended to within seven working days.
- Referrers are respectfully requested to exercise a little patience and understanding
  whilst their case is moving up the schedule. Email requests for delivery dates are not
  acknowledged to save time and administration resources.
- Our service aims to address the *spiritual* health of the referred Patient only.
- We cannot offer psychological therapy or healing for the physical body.
- Advice for post-intervention well-being is always given on session recordings.
- We don't have the resources to provide aftercare or therapy following our intervention.
